The QLD Branch will be hosting their annual residency showcase on **13th of February 2024**. This event will be held **online and face-to-face** at the Royal Brisbane & Women’s Hospital, Brisbane from 5:30 to 8PM.

Foundation Resident Pharmacists are invited to present a **lightening talk** at the showcase.

This event aims to provide residents an opportunity to showcase their work to their fellow pharmacy community in a relaxed, stress-free environment. It is a great opportunity for resident pharmacists to work up and receive feedback on their presentations/projects that they may consider submitting for events such as Medicines Management or SHPA Resident of the Year Competition.

There will be **cash prizes** to the value of \$300 to be awarded on the night.

Eligibility

Foundation Resident pharmacists must:

- Be a foundation resident in Queensland
- Enrolled in the SHPA Foundation Residency program
- Be undertaking their residency training in **2024** or have completed their foundation residency in **2023** and did not present at the QLD Branch annual residency showcase in 2023.

Requirements

Presentations should be a **maximum of 3 minutes and a maximum of 6 slides** (including title and references). Presentations should showcase a key achievement from your residency (case discussion, project, reflective piece, DUEs).

There will be no slide template provided but participants are encouraged to include the following:

Title	
Background	Should briefly describe the background/rationale for the key achievement (eg. study, service, program, problem, need).
Aims/Objectives	Statement of aims and objectives.

Methods / Actions	Summary of the study design, methods, intervention, service, role. Actions taken to identify/resolve problem or implement change/service/case.
Results / Evaluation	Include a summary of the main results or evaluation of project / case.
Conclusions / Learnings	Include a summary of the main conclusion and interpretation of the results which are supported by the data. Consider the implications of the project/research and usefulness to current and/or future practice. What did you learn?
