

## Information for Authors

*Pharmacy Growth, Research, Innovation and Training (Pharmacy GRIT)* is a complementary journal to the *Journal of Pharmacy Practice and Research (JPPR)*, which has been the official peer-reviewed journal of The Society of Hospital Pharmacists of Australia (SHPA) since 1966. *Pharmacy GRIT* is published quarterly, and, like the JPPR, supports the development of pharmacy practice by providing a forum for the exchange of knowledge, ideas and professional opinion for pharmacists and pharmacy technicians from all practice settings. It also published feature articles and instructional papers of use and interest to SHPA members.

*Pharmacy GRIT* is published in-house at SHPA's Federal Secretariat.

### MANUSCRIPT SUBMISSION

Manuscripts should be submitted by one of the authors via email, to [GRIT@shpa.org.au](mailto:GRIT@shpa.org.au). If the GRIT staff believe your submission may be more appropriate for publication in the JPPR, they will contact you to discuss this possibility.

Manuscripts must comply with the following:

### Covering Letter

In the covering letter include the:

- title of the manuscript;
- name, address, telephone and facsimile numbers, and e-mail address of the corresponding author;
- a statement that none of the material has been published previously, is under consideration, or has been accepted for publication elsewhere;
- a statement of competing interests – authors must declare financial or other relationships that might lead to a conflict of interest;
- a statement that all persons listed as authors have read and given approval for the submission of the manuscript;
- a statement that the head of the department in which the work was carried out has given permission for the manuscript to be published;
- when studies involve experimental investigations on humans, a statement that the subjects provided informed consent and the name of the institutional ethics committee that approved the study; and
- a statement that the submission complies with the manuscript checklist (at the end of this document).

### Title Page

On the title page include the:

- title of the manuscript (concise but informative);
- full name (including middle initial, and with surname specified), qualifications, title and address of position held when the manuscript was produced for all authors;
- name, business address and e-mail address of the corresponding author; and
- word counts of the abstract and text (excluding title page, tables, figures, acknowledgments, references).

### Manuscript Preparation

- Follow the requirements in this document, the reference citation guide <<https://www.shpa.org.au/resources/GRIT-reference-citation-guide>> and the 'Uniform Requirements for Manuscripts Submitted to Biomedical Journals' <[www.icmje.org](http://www.icmje.org)>.
- For further guidance on style, consult recent issues of the Journal and the *Style Manual for Authors, Editors and Printers* (6th ed. Canberra: Commonwealth of Australia; 2002).
- Use abbreviations sparingly.
- Use the System International (SI) units.
- Write numbers one to nine in full, except when they are attached to units of measure.
- Use generic drug names except when mentioning a specific proprietary preparation.
- Submit manuscript in Word, double-spaced and in Times New Roman 12 pitch.
- Number the pages consecutively starting with the title page.
- Include headings and subheadings to divide the manuscript into appropriate sections.
- Place tables, figures and appendices on separate pages at the end of the manuscript.
- Do not add text as headers, footers or footnotes.

### Authorship

Each author should have participated sufficiently in the work to take public responsibility for its content. This participation should include:

- conception and design of study, or acquisition of data, or analysis and interpretation of data;
- drafting the manuscript or revising it critically for important intellectual content; and
- giving final approval of the version to be published.

Participation solely in the collection of data or acquisition of funding does not justify authorship. General supervision of the research group is not sufficient for authorship. The order of authorship should be a joint decision of the authors.

### Acknowledgments

Persons who have contributed to the manuscript but whose contribution does not justify authorship may be acknowledged and their contribution briefly described. Such persons must give their permission to be named. Financial and material support should also be mentioned.

### Copyright Assignment

Once a manuscript has been accepted for publication, authors will be required to assign copyright to *Pharmacy GRIT*. Original signatures of the authors are required. With multiple authors, signatures may be submitted on separate forms.

Published articles may not be reproduced, in whole or in part, without permission from the publisher. Authorisation to copy items for internal or personal use is granted by SHPA for users registered with the Copyright Clearance Center Transactional Reporting Service or Copyright Australia Limited.

## References

- Accuracy of the references is the responsibility of the authors.
- References should be verified by the authors against the original documents.
- References should be numbered consecutively in the text in the order in which they are first mentioned, using superscript numbers after the punctuation.
- References cited only in tables or in legends to figures should be numbered in a sequence established by the first identification in the text of the table or figure.
- Automatic referencing should not be used.
- References should be cited according to the Journal's reference citation guide <<https://www.shpa.org.au/resources/GRIT-reference-citation-guide>>.

## Tables

- Information contained in the tables should not be duplicated in the text.
- Tables should have a concise but informative title.
- Present tables in double-spaced type on separate pages.
- Number tables consecutively in the order in which they are first cited in the manuscript.
- For footnotes use these symbols in the following sequence: \*, †, ‡, §, ||, ¶, \*\*, ††, ‡‡, §§.
- Explain abbreviations in the footnotes.

## Figures (graphs, images, illustrations)

- Submit figures in electronic format.
- Images may be embedded in the manuscript but the original image file must also be sent separately.
- Images must be of high resolution.
- Preferred format for image files are PDF, EPS, JPEG and DOC.
- For graphs in Excel, the complete Excel file must be provided, including the data table.
- Number figures consecutively in the order in which they are first cited in the manuscript.
- Figures should have a concise but informative caption.
- Provide a letter of permission from the copyright holder for the use of images from other publications.
- Provide informed consent from persons identifiable in an image.

## MANUSCRIPT CATEGORIES

*Pharmacy GRIT* invites submissions under the following categories: research, pharmacy practice, review, case reports, letters, opinions and feature articles, as well as submissions to *The Tonic*. All research, pharmacy practice, case report and other scientific submissions will undergo external peer review by at least one expert. A statistical review may also be sought from the Journal's consultant statistician. The requirements for each category are detailed below.

### Opinion and Feature articles

### Research

- original research only;
- text limit 3000 words, reference limit 25, tables/figures limit 4;

- structure abstract (limit 250 words) under headings: Background, Aim, Method, Results, Conclusion; and
- structure text under headings: Introduction, Method, Results, Discussion.

### Pharmacy Practice

- any aspect of contemporary pharmacy practice;
- text limit 2500 words, reference limit 25, tables/figures limit 4; and
- unstructured abstract (limit 150 words).

### Review

- critical analysis on current topics of interest;
- systematic reviews preferred, although narrative reviews accepted;
- text limit 3000 words, reference limit 50, tables/figures limit 4;
- specify details of bibliographic data sources (date range, indexing terms, limits) and criteria for study selection;
- summarise the main results and provide an interpretation of the studies; and
- structure abstract (limit 250 words) under headings: Aim, Data sources, Study selection, Results, Conclusion.

### Case Reports

- novel drug treatments that are not widely documented, have had a major impact on patient outcome or are of educational value;
- text limit 1500 words, reference limit 15, tables/figures limit 2;
- structure text under headings: Introduction, Case report, Discussion. No abstract required.

### Letters to the Community

- brief reports, comments on current topics of interest, comments on Journal articles, corrections of previously published material  HER  EDGL  DGER  WU
- text limit 500 words, reference limit 5, tables/figures limit 1.

### The Tonic

- submissions to *The Tonic* are limited to 300 words, and no cover letter or title page is required.

## MANUSCRIPT CHECKLIST

Check that you have complied with the following before submitting your manuscript:

- covering letter with all details and statements;
- title page details completed;
- word counts for the abstract and main text (excluding title page, tables, figures, acknowledgments, references) do not exceed limits;
- no headers, footers, footnotes or automatic referencing;
- abstract complies with requirements for structure and text limit;
- manuscript complies with requirements for structure and text limit;
- sufficient headings and subheadings in the text to divide sections;
- number of tables/figures does not exceed limit;
- separate graphic files are provided for figures embedded in the text;
- acknowledgements are noted; and
- references are in the correct format.
